WARNING

Under Kansas law, there is no liability for an injury to or the death of a participant in domestic animal activities resulting from the inherent risks of domestic animal activities, pursuant to K.S.A 60-4004. You are assuming the risk of participating in this domestic animal activity.

Inherent risks of domestic animal activities include but shall not be limited to:

1. The propensity of a domestic animal to behave in ways i.e. running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in an injury, harm or death to persons on or around them;
2. the unpredictability of a domestic animal's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals;
3. certain hazards such as surface and subsurface conditions;
4. collisions with other domestic animals or objects; and
5. the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the domestic animal or not acting within such participant's ability.

Helmet Policy:

It is statistically clear that there are certain inherent dangers associated with horseback riding. One of those dangers is the risk of suffering serious head injury should the rider fall or be thrown from his/her horse. It is, therefore, the policy of Redbird Farm and it's assigns, that safety riding helmets will be worn at all times when riders are mounted on a horse.

_____ I am aware that protective head gear which meets or exceeds the quality standards of the SEI certified and ASTM standard F1163 equestrian helmet, should be purchased and worn by me and/or my child while riding and being near horses, and the wearing of such helmet may reduce the severity of some head injuries and may prevent my serious injury or death as a result of a fall or other occurrence. I am aware that until I purchase such helmet, one is available for my or my minor child's use from Redbird Farm. If I or my minor children do not wear a helmet, it is because we so choose.

_____ I acknowledge that there is a possibility of injury when riding or working with horses. I hereby release Redbird Farm, its owners, executives, employees, property owners, and all heirs from any and all liability for any injuries that I may receive while preparing to ride, mounting, riding, dismounting, handling horses, and any other activities not listed but which may pertain to my participation with or visiting Redbird Farm.

_____ I fully understand the danger of this activity and the possible harm which may result. I further understand that by signing this document that I am releasing my rights to seek recovery from Redbird Farm, its owners, the property owners, executives, employees and their heirs. I also acknowledge that this total waiver shall operate to prevent my spouse or my heirs from pursuing any such action arising out of this activity.
